## Reflections from Judge JoAnn Colvin (NY) Judge for Dogs, Intersex, and Best Veteran

Thank you to Michelle Keehn, Toni Raden, the 2015 NSS Committee and the ACC for inviting me to judge the NSS in Wisconsin. It was truly a high point- both as a breeder and a judge. I thank all the exhibitors for their courtesy, good humor, and competent presentation of our breed. I was impressed by the happy attitudes of all the dogs- something that wasn't always true in the past.

I'd like to comment, in general, on some aspects of the breed. We need to be sure we breed to the standard and not to personal preference. Heads are one example. The Chesapeake is not meant to have a "blocky" head. We need to be concerned about retaining high ear sets and small ears.

The standard calls for a medium stop and a pointed but not sharp muzzle. We should not be breeding for short muzzles, or squared-off muzzles. The dogs should have tight lips- unfortunately too many exhibit loose and wet flews. I also did see some questionable bites so attention is needed there. Another concern to be watched is the lack of eye rim pigment.

Outline and balance is another important aspect of which breeders should be aware. We need to be careful to preserve the classic underline- chest at least to the elbow, short loin, and well tucked-up. Some Chesapeakes are coming too close to a straight underline (think Labrador). Shoulder angle needs to balance with rear angulation. Overangulation in the rear affects the balance of the outline. It results in a slope of the croup, low tail set, high tail carriage, and a side gait in which the rear over reaches the front.

I was pleased to see that most of the dogs were in good condition and moved with athleticism. We must be careful to select for dogs that show the power in the rear that the standard mentions.

Gait should show reach and drive and the dog should cover ground in an effortless way- neither mincing nor pounding.

Almost all the dogs were in fine coat- good undercoats and proper texture. There were perfectly acceptable variations in waving patterns and colors. I

enjoyed seeing the variety which is a hallmark of the breed.



In my 30+ years of involvement with the Chesapeake Bay Retriever, I feel breeders should be proud of their advances in promoting the breed in all venues. Many "old time" breeders are reaching the end of their careers. I would challenge new breeders to learn, learn, learn from the "old folks" to move ahead with continued improvement in the quality of our breed.

## Comments from Judge James Covey (NY)

### Judge for Bitch Classes

Thank you to the members for the honor of judging bitches at your National this year. A great thrill for me. I found overall quality to be very good. Many of my choices had to come down to personal preferences because of the depth in some of the classes. There were only two questionable bites and just one bitch where I found coat to be, to me, incorrect.

Three classes stood out as being so strong that placements could go another way on another day. The bitches placing in the 12-18 Classes, the Bred by Exhibitor, and the Open classes were excellent and my choices were difficult.

I found my Winners Bitch from the Open Class. A moderate bitch who owned the ring, moving effortlessly around. She was of correct size and wonderful type. Her head and expression, along with her ring presence won her the day.

My Reserve Winners Bitch from the 12-18 Class was a very sound bitch, moderate in all respects and certainly should make her breeder and owner proud.

I would also like to mention the quality of my Bred By Class winner. Her type, soundness and correct coat made her a stand-out in the class.

Finally, what a pleasure to have so much quality in the "non regular" classes. The "old girls" and the Hunting and Field bitches certainly did the breed proud.

Thank you again for the opportunity and the hospitality. You are a wonderful group of sportsmen and women.



## Afterthoughts from Sweepstakes Judge Meghan Conner Timmerman (SC)

What a thrill to judge the sweepstakes at the American Chesapeake Club's National Specialty Show in 2015. Thank you to the committee for this honor and to all the exhibitors who entered under me.

Dog shows in recent years have lost the primary objective that they were intended for and that is not to create champions, but to evaluate breeding stock. When a breeder steps into the ring to judge their own breed it is a responsibility to keep this foremost in mind; which bitch would I take home to incorporate in my breeding program? Which dog would I, in fact, take my bitch to?

When I am evaluating the Chesapeake, general outline is imperative for my choices. When I look across a field or a ring I want to be able to tell that the dog is a Chesapeake with absolute certainty. That across the way, that outline is 100% Chesapeake. If a Chesapeake's outline lends itself to the certainty of our Standard, we have, in fact, done our job as breeders and guardians of the breed.

The Chesapeake head is second to coat on the point scale and rightly so as the job of the breed is dependent on it. The Chesapeake is

not meant to have a head of hard, square lines. There is such a fine line between strength of head and a head that is over done. And, perfecting a strong, noble expressed head is an art in itself.

To quote Janet Horn:

*"On head, ears are set high because this is a swimming dog, and lower set ears will ship more water. In reading "broad and round," we refer back to the table of measurements at the end of the Standard, where we find distance from root to root of ear to be five to six inches- not, please, ten to twelve inches. We are **not to construe this as meaning the broader the better.** The proportions of the head given here are drawn from these measurements.*

*I do not know why one sees so many loose, thick pendulous lips and the appearance of a squared off muzzle in this breed, when the Standard is so clear on this."*

Eye shape was a concern coming away from my judging. The eye shape is an important part of expression unique to the breed. A round, headlight shaped and coloured eye is completely incorrect and should bred away from.

Correct frontal assemblies are the single hardest part of any dog to breed.

Head, neck and shoulders are illusive in the breed unfortunately. Please learn what a correct front end is and apply this knowledge to your breeding choices.

My Best In Sweepstakes Puppy, Chesarab Chestnut Cara was a lovely bitch of correct outline and breed type. Her coat was exceptional and she moved freely around the ring. Her outline was so Chesapeake I think you could see she was a Chesapeake from another state. Best of Opposite in Sweepstakes Puppy, Brimstones Circle of Life, was a male from the 15 to 18 class that possessed lovely lines to his head and outline. His topline was exceptional and, again, true Chesapeake type. The 6 to 9 puppy, Ironstone 3-D's Blaze of Thunder was an exceptional charge and worth mentioning; his outline going around the ring was spot-on and he was a joy to judge as well.

My veterans were a sight to behold and anyone ringside was treated to a very special entry of dogs to learn by. In all my sweeps classes I tried to have the dogs shown as freely as possible and to use that gorgeous ring the committee provided for everyone to see as much of each entry as possible. The veterans sure did not disappoint!

My Best Veteran in Sweepstakes, GCH Chestnut Hills Watermark was a bitch not unfamiliar with the winner's circle as she has represented our breed scores of times and we are better for it. Her outline, particularly her topline for ten years of age was a clinic for anyone wanting to know more about the breed. Coat exceptional. Lovely undercarriage and carried herself in a manner only our breed can. Best Opposite Veteran in Sweepstakes was a hard choice for me coming down to 10 years and over winner, GCH



## New Champion Tracker

On December, 6, 2015, Splash passed her Variable Surface Tracking test at Lane Community College in Eugene, OR under judges Curt Curtis and Karla Curtis at Emerald Dog Obedience Club's test. Splash is now **CT Yakity's Flying D Splish Splash VCD2, JH, RA** (Crackshot's Ben There Done That X DC, AFC Genny's Yakity Yak Don't Talk Back MH). Splash was bred by Linda Harger and Tom Ivy and is owned and loved by Dean and Sally Diess. Trained and handled by Sally.

I knew from the start that Splash was going to be a very good tracker. Maybe even better than my first CT Chessie, Flying D's Cappuccino Freeze, UD, JH, WDX. Her focus and dedication to following and staying on the track showed up from the first time I put her in a tracking harness. She passed her TD test at 7 months and her TDX the following fall at 18 months (both first attempts). Then we got caught up on some other parts of her life like obedience and field work before we got too serious about VST training. We entered her first VST test in December 2011. This time was her 6<sup>th</sup> attempt. We have learned a lot along the way like not to let feral cats and squirrels un-focus you, and to not run to grass because it looks like more fun than settling into finding that hard surface turn, or not running to something that might be an article instead of staying on the track.

Our track was 635 yards long, fairly even in vegetation and non-vegetation and had 6 corners. It was a good track for Splash in that the vegetation was nicely dispersed along the track. Her "moment of truth" turn was in a parking lot and she worked it very well. I just had to be patient and let her work it out as she checked out all the fringes before she committed. Once she did, it looked like she was sucking up the asphalt

by. This driver couldn't make up his mind where he wanted to go and so a delay, but Splash very happily headed for the grassy medium after the car passed and I hoped the track actually went there because she sure wanted that grass. It did. The rest of the track went well with some circling at one corner to find the right angle of the next leg (the one with the metal article on it) and then I could have sworn we were going to end up in the blackberry bushes with no way out but there was a path that led back into another parking lot which was our final leg. The final article was a soft piece of leather that just matched the parking stripe it was placed on and when I saw her head for it and saw what it was, I wasn't sure whether to cheer or panic. Splash has been known to swallow soft pieces of leather. I made a dive for her as soon as she picked it up and yelled "drop it" and then I cheered.

Thank you to all who helped make this dream come true but especially to Splash who has been a wonderful traveling companion on our journey to the CT.



## Health Committee Report

### New Vaccine for New Strain of Canine Influenza

It has been announced that a vaccine for the new strain of Canine Influenza Virus H3N2 has received conditional approval from the USDA. Conditional approval expedites the vaccine licensing in emergency situations to avert epidemics of the disease.

The new virus of Canine Influenza has been reported in 25 states since the initial large outbreak in Illinois and Wisconsin. Its' great threat lies in little to no immunity in the dog population. That means your only protection is vaccination. The virus is highly infectious, 80% of dogs exposed get sick. The sickness lasts 2 to 3 weeks. There is a low death rate. A new vaccine rushed forward may have unexpected reactions.

The producers of the vaccine are Merck Animal Health and Zoetis, both highly respected Pharmaceutical firms. It seems with the multiple pros and cons of the vaccine, discretion is a good guide. If you are at high risk of exposure the vaccine is wise. If you are not in a highly traveled canine area and or in a high risk area you probably should wait to use the vaccine. If possible use the vaccine only on healthy stress free animals.

## AKC Delegate's Report

The December 2015 quarterly meeting of the American Kennel Club featured several administrative changes in Conformation, Grand Champion levels as well as the preservation of a By-Law proposal dealing with the AKC Board of Directors.

The Board and Delegate body approved changes to the following Dog Show Rules: Chapter 4 section 2, Chapter 7 section 12 and Chapter 12 sections 1, 3, 4 and 6. All of these changes involve substituting "published and available" for the current wording "printed and sent". These changes will allow clubs the OPTION of utilizing electronic premiums, programs and catalogs. Printed materials may still be used.

Changes to Chapter 16 section 7 of Dog Show Rules regarding Grand Champions was also approved establishing the following Grand Champion levels: Bronze 100 points, Silver 200 points, Gold 400 points Platinum 800 points and Platinum "X"(2 and above) for every additional 800 points.

The Delegate body rejected a proposal that would remove term limits for the AKC Board of Directors. The current rule limiting Board members to two 4 year terms and requiring at least a 1 year hiatus before seeking re-election has been maintained.

The AKC continues to investigate methods to increase dog registration. Registration is not only for participation in AKC events but is important in tracking health trends and genetic diseases. In a 2014 comparison of litter registration to puppies actually being registered with the AKC. We are doing better than most breeds. Labs are at 40% and Golden Retrievers at 39%. Strategies are being discussed in how to better encourage breeders to have their buyers register puppies. Every breed club is being asked for recommendations. Please contact me if you have any suggestions.

How to better manage the Retriever Master National continues to be a topic of concern. An Amateur Master National is being considered.

## Minutes of October 8, 2015 Annual Meeting

The annual meeting of the AMERICAN CHESAPEAKE CLUB, a California Nonprofit public benefit corporation, was called to order at 7:20 PM CDT, Thursday, October 8, 2015. The meeting was held in Oconomowoc, WI at the 2015 NSS.

The following officers and directors were present: Linda Harger, President; Gale Frana, Treasurer; Lynda Barber-Wiltse, Secretary; Gary Boyce, Director; Jill Conroy, Director and Betsy Humer, Director.

Linda Harger served as chair and Lynda Barber-Wiltse served as secretary of the meeting. The meeting began by recognizing the recent loss of two Chesapeake Bay Retriever friends and champions:

- Sue Cone (NJ) – a long time ACC member, earned the first OTCH on a CBR (ultimately titling 4 to OTCH), obedience mentor to many of us across the country, tireless advocate for our rights to own dogs; and
- Gary Sheetz (FL) – professional handler, owned Raven.

**Roll Call:** Fifty-one (51) people signed the sign-in sheet (includes 3 guests). A quorum was not established for this meeting (requires 10% of 1185 members, or 119 members). President Linda Harger introduced herself then asked members and guests to introduce themselves.

**Minutes of the last meeting:** Minutes were published in the September/October 2014 Bulletin (July 21, 2014, meeting at the Carnation, WA NFTS). The secretary had copies available for members to review, if requested.

**Report of the President:** President Linda Harger thanked outgoing President Joanne Silver and Director Emelise Baughman for their service to the Club and presented plaques to them. The President stated the

Health Committee (Chair Jim Stewart) – The committee is active in a variety of areas – supporting Joan Coates, DVM and her research on degenerative myelopathy (DM) at the University of Missouri; the DNA collection and storage (at the 2015 NSS and NFTS) will protect our breed now and in the future; working in collaboration with the ACC and the ACCCT on health issues; supporting post mortems for dogs diagnosed with DM.

American Chesapeake Club Charitable Trust (ACCCT) (Chair Diane Mazy) – Diane explained the relationship between the ACC and ACCCT (they are a separate entity focusing on health, rescue and education for CBR's); information is periodically posted in the Bulletin; the ACCCT contributed to research about bloat/torsion; contributes funding to DM research and assistance for post mortem data collection for dogs with DM

(CBR's are one of the few breeds where individuals tested "carrier" become "affected").

JBEC (Judge and Breeder Education) Report (outgoing Director Emelise Baughman) – the committee has facilitated many breed education seminars (See August 31, 2015 Board Teleconference minutes); 4 judges are signed up to observe the 2015 NSS; Patty Martin will provide a handling session.

Lifetime Achievement Award Committee (LAA) (Chair Toni Raden) – a couple of things are in the works.

Show Committee (Chair Christy Gonzales) – Michelle Keehn and Toni Raden inherited a lot of work for the 2015 NSS. The 2016 NSS will be in Portland, OR, in October (Marilyn Williams is Chair) – the Judging panel is: Carl Liepmann (dogs); Betsy Humer (bitches, intersex); Annette Monugian (veteran and puppy sweepstakes). The committee is seeking chairs/committees for 2017 (East) and 2018 (option for Purina Farms, St. Louis with other national breed club show specialties). Brenda Stewart asked about updates to the survey for show and sweepstakes judges.

Breed Rescue (Chair Linda Harger) – the ACC needs help, volunteers/people to foster, go rescue dogs, pay attention and follow-up with breeders.

Editorial Committee (Director Lynda Barber-Wiltse) – Bulletin Editor Marty Smith is doing a great job.

ROM Program (Director Lynda Barber-Wiltse) – updating the program to incorporate new titles and venues.

## Minutes of November 9, 2015 Regular Board Meeting

A regular meeting of the board of directors of the AMERICAN CHESAPEAKE CLUB, a California Nonprofit public benefit corporation was called to order 7:02 PM EST, Monday, November 9, 2015. The meeting was held by telephone conference call through which all persons participating in the meeting could hear and speak to one another.

The following officers and directors were present: President Linda Harger, Vice President George Marthinuss, Treasurer Gale Frana, Secretary Lynda Barber-Wiltse, Director Ed Bahr, Director Gary Boyce, Director Jill Conroy, Director Heidi Henningson and Director Betsy Humer.

President Linda Harger served as Chair and Secretary Lynda Barber-Wiltse served as Secretary of the meeting.

To approve minutes from the Annual Meeting (October 8, 2015 at NSS in Oconomowoc, WI). **15:42a** (Linda Harger, Heidi Henningson) Passed 11/9/15.

**Report of President:** The President (Linda H) welcomed all to the first teleconference and reported that the ACC has been quiet.

**Report of Secretary:** The Secretary (Lynda B-W) reported the following motions have been approved by unanimous written consent of the directors, effective on the dates noted, and the consents will be filed with the minutes of this meeting.

To appoint Dawn Logan as the ACC Statistician, effective October 1, 2015. **15:41** (Joanne Silver, Lynda Barber-Wiltse) Passed 9/11/15.

To appoint Dawn Logan (PA) to the ACC Electronic Communication Committee (ECC) for 3 years (10/2015 thru 09/2018) **15:42** (Joanne Silver, Michael Moscovitz) Passed 9/17/15.

The Board reviewed and updated the AKC information regarding club officers and key positions.

**Report of Treasurer:** The Treasurer (Gale) reported the Funds on hand as of November 9, 2015: BB&T (\$130,502.23); Huntington (\$2,119.32); Foothills Checking (\$8,819.33); Foothills Savings (\$35,000.76) and PayPal (\$8,265.30) for a total of \$184,706.94. Gale stated the transition in the treasurer position is going very well ... past Treasurer George Marthinuss is very organized and a wonderful tutor. George and Gale are moving all funds from BB&T and Huntington to the Foothills accounts. The Huntington account will be closed as soon as all checks have cleared and all funds will be transferred to Foothills savings. The CD worth a little over \$100,000 at BB & T will mature on November 27, will be cashed out and transferred to the Foothills savings account. The Foothill savings account is currently earning 0.4% on deposits. George and Gale will evaluate the rates available in the beginning of December to determine where our best rate of return is for these funds. Gale also thanked George Makatura for his software work and assistance with the transition. The 2015 National Show Specialty and the 2015 National Field Trial Specialty accounts are waiting on checks to clear. Once all checks are cleared, the excess funds will be transferred to our Foothills accounts. The Show Specialty is expecting to show about \$700 - \$800 profit. The NSS WD has completed their financials and showed a profit of \$408. The Field Trial Specialty is expecting to show about a \$4,000 profit. Membership renewals are coming in at a steady rate. As of noon today (November 9), 263 members have renewed.

**Reports of Committees:** The Board reviewed and updated the ACC Standing and Ad-Hoc Committee and assigned Board member liaisons list.

### Standing Committees

Companion Events Committee (Jill) – no report this meeting.

Electronic Communication Committee (George) – George Makatura is sharing information with the committee on how to use the Constant Contact and Blast Email tools.

Field Trial Committee (Linda) – To appoint Heidi Henningson (NE) as Chair of the Field Trial Committee for two years (11/2015 thru 10/2017) and to appoint Julie Cole (CA) to the Field Trial Committee for three years (11/2015 thru 10/2018). **15:44** (Linda Harger, Betsy Humer). Passed 11/9/15.

Health Committee (Betsy) – the health clinic/ blood draw for the OFA CHIC DNA Repository collected 70 samples at the NSS and 52 at the NFTS for a total of 122. The expenses were approximately \$1,851 (less than what was authorized). The project was very well received. The Health Committee is active and a great resource to our ACC members.

Hunt Test Committee (George) – the 2015 Master National Event was held at H. Cooper Black, Cheraw, SC, October 15-25. There were approximately 900 dogs entered and 272 passed. The 2016 event will be held in St. Louis, MO. Pleased to see some new CBR's joining in the hunt tests.

Judge and Breeder Education Committee (JBEC) (Betsy) – The dog handling workshop at the 2015 NSS was successfully presented by Patty Martin. The Judges Seminar at the 2015 NSS was successfully presented by Betsy Humer. Dyane Baldwin had been approved to give the judges seminar at the 2015 AKC Sporting Institute in Florida in December. She is unable to attend so Betsy has agreed to do the presentation. Melissa Schumann will be giving a judges seminar in Washington in January. Renee Wolfe (CO) applied to be an ACC mentor and was approved unanimously by the JBEC.

Lifetime Achievement Award Committee (Linda) – all committee members' terms will soon expire.

Show Committee (Jill) – The committee submitted the list of eligible judges for national show specialties to the JBEC for their input, then amended the list to reflect their recommendations. The list will be included in the next Bulletin for member voting. The committee is preparing proposals for revisions to the NSS Judge Selection Policy and to the NSS Show Chair Policy. A summary of those revisions will be forwarded to the board when completed. A list of all approved supported entries will be listed in the next Bulletin and the committee is working on soliciting additional supported entries. 2016 NSS - In regard to the concern of the club contract with the 2015 host hotel and the issue of getting stuck with the cost of unused rooms, the committee has revisited this issue and feels comfortable the issue is well under control by Marilyn between her knowledge of the area, hotel and past experience with this hotel in general. Illustrated Guide (IG) Update – Linda H provided a history of the AdHoc committee work product and relayed the JBEC is collecting input for a future update. Many members have expressed concern about the IG versus the CBR Standard. The Board will include a request for input into the IG update in a future Blast Email.
