

Update on Degenerative Myelopathy Research from University of Missouri

This summer the ACC Charitable Trust and Health Committee received an update on the Degenerative Myelopathy (DM) research. Below is a summary of the update. If you wish to learn more about DM in the Chesapeake Bay Retriever or wish to learn more about participating in any of the ongoing DM studies, please contact Briedi Gillespie on the Health Committee at b.gillespie@usu.edu.

First and foremost Dr. Coates and her team thanked the ACC Charitable Trust and members of the ACC for playing such a supportive role in the study of canine degenerative myelopathy (DM). They acknowledge that the Chesapeake Bay Retriever (CBR) breed has played an important role in the original (*SOD1*) gene mutation discovery and remains a key breed in the ongoing DM research. They continue to investigate many aspects of DM as an important veterinary disease and as a model for human amyotrophic lateral sclerosis (ALS).

Currently, through the Molecular Genetic Diseases Laboratory / Orthopedic Foundation for Animals, 3273 CBRs have been tested for the presence of the *SOD1* gene mutation with the following results: 1388 normal (*CLEAR*), 1392 *CARRIER* and 493 *AT RISK*. So far they have performed necropsies on 22 CBRs with clinical signs of DM and 2 CBRs donated for control tissues. They have documented DM in 14 of those dogs: 13 tested homozygous *AT RISK* and 4 tested heterozygous *CARRIER*. The remaining 5 dogs did not have histopathologic confirmation of DM and a different disease process was causing the signs of hind limb weakness. Please note that the dogs chosen for participation in this study were not randomly selected (owners *volunteered* their dogs for participation in the study), so the high heterozygous to homozygous ratio for DM-affected CBRs listed above does not represent the overall ratio of DM in the whole CBR breed. Nonetheless, researchers still continue to identify more *CARRIERS* with DM among CBRs than they have found in any other breed. In the long run, the identification of genetic factors that influence the susceptibility to DM could lead to the development of novel therapies that could benefit both dogs with DM and human patients with ALS.

Your Help Is Still Needed For These Studies!

If you have not tested your CBR for the DM *SOD1* gene please do so! Instructions for testing can be found by going to the website: <https://www.ofa.org/diseases/dna-tested-diseases/dm>, Scroll down to "Order DNA test" and follow subsequent instructions. Samples can be submitted as cheek swabs through the OFA or as blood samples (recommended) sent directly to the laboratory at University of Missouri. All proceeds either through the OFA or directly to the lab at Missouri directly benefit research of DM genetics.

If your CBR has or develops signs that your veterinarian thinks are consistent with DM: The University of Missouri still needs post-mortem samples from dogs who have DM, especially if your dog has already been tested as *AT RISK* or *CARRIER*. Please consider having him/her contribute to the study. Contact the ACC DM liaison Briedi Gillespie (see below) to receive the most updated protocols. *Please note that as much notice as possible is needed to coordinate collecting the samples. We cannot coordinate with only a few days notice due to collection and shipping restraints.*

Help is available for the cost of contributing to these DM studies: The ACC Charitable Trust continues to provide monetary support for the cost of the sample collection (necropsy) for CBR's to be a part of the DM study. If you have a CBR that shows signs of DM and you wish to contribute to the study, please contact the ACC DM liaison Briedi Gillespie with as much advance notice as possible at b.gillespie@usu.edu or (208) 301-1592 for the most current protocols and for help coordinating the procedures.

Update on Genetic Modifier Study in the CBR

Ongoing research at the University of Missouri continues to look for genetic modifier genes that may influence DM's susceptibility and age-at-onset for CBRs with the (homozygous) *AT RISK* test result and dogs with the (heterozygous) *CARRIER* test result. In very basic terms, this research is looking at what additional genetic factors may determine whether an animal with one or more copies of the *SOD1* gene will get DM, and also what genetic factors might determine the age at which a dog with DM will start showing signs. To investigate and identify these genetic modifiers, the researchers are using genome sequencing. Specifically they are generating and evaluating the whole genome sequence of a CBR that developed DM even though it was heterozygous *CARRIER* according to the *SOD1* test for DM. For comparison, they would also like to generate and evaluate the whole genome sequence of an older CBR that tested homozygous *AT RISK* but has **not yet** developed DM. *Thus, researchers are actively looking to collect a blood sample from an AT RISK dog that is 12-14 or older years of age and not*

showing signs of DM. If you own such a dog and would like to donate a blood sample for genome sequencing, please contact Briedi Gillespie at b.gillespie@usu.edu or contact Liz Hansen directly at the University of Missouri at HansenL@missouri.edu.

Clinical Trials for Treatment of DM

Two clinical trials are currently open to all breeds/dogs with early signs of DM. The purpose of these studies are to evaluate promising new drugs to treat DM with hopes to slow disease progression. One trial tests a drug that is said to directly 'knock down' the production of the protein *SOD1* which is produced by the *SOD1* gene and slow the progression of the disease. Another trial evaluates a gene-therapy approach also to 'knock down' *SOD1* production by the *SOD1* gene to produce similar effects on the progression of the disease. Both of these drug therapies have been tested in a preclinical setting for safety in dogs. Both of these drugs must be injected directly into the animal and the researchers need to monitor clinical disease progression, so travel to

the University of Missouri is necessary for participation. *Both studies will be randomized and double blinded; meaning the investigator and the pet owner will not know whether the dog receives the drug. Some dogs will receive the drug and a smaller percentage of dogs will receive only the vehicle. Based on the randomization design, the participant dog has a 67% chance of receiving the therapy for the first study and an 80% chance of receiving the therapy for the second (gene-therapy) study.* If you would like more information on these studies and/or wish to participate, please contact Liz Hansen at the University of Missouri at HansenL@missouri.edu.
